- **absolute monarchy:** a system of government ruled by a monarch who has control of the government and state. (LO 11.2.1)
- **absolute poverty:** a threshold in which an individual does not have enough resources to meet their basic survival needs. (LO 8.3.1)
- **achieved status:** a position within a social system that is gained through merit. (LO 5.2.1; LO 8.2.1)
- **affirmative action:** policies designed to promote educational and job opportunities for minorities and women. (LO 10.2.2)
- **agents of socialization:** individuals, groups, and institutions that influence the attitudes and behaviors of members of society. (LO 4.2.1; LO 7.1.1)
- **amalgamation:** the creation of a new group as a result of the combination of a minority and majority group. (LO 10.5.1)
- American Dream: a commonly held belief in the U.S. suggesting that anyone can overcome obstacles and get ahead in life through hard work and determination. (LO 8.2.1)
- American Sociological Association (ASA): a national organization for sociologists dedicated to advancing sociology as a scientific discipline and profession serving the public good. (LO 2.1.2)
- **anomie:** the breakdown of social values, norms, and order resulting in social instability. (LO 1.4.1)
- **anonymity**: concealing the identities of participants within the research project. (LO 2.1.2)

anticipatory socialization: the process of learning different behaviors or activities in an effort to aspire to group membership. (LO 4.3.3)

apartheid: policies, regulations, and laws implemented by a government to keep racial and ethnic groups separate. (LO 10.3.2)

applied sociology: the use of sociological theory, research, and methodologies to find solutions to problems in society. (LO 1.5.2)

ascribed status: a position within a social system that is assigned based upon characteristics such as sex, race, or economics. (LO 5.2.1; LO 8.2.1)

asexual: individuals who are not sexually attracted to others. (LO 9.4.1)

assimilation: the process in which minority groups lose their distinct cultural characteristics and are absorbed into the dominant group. (LO 10.1.5)

authoritarian leader: a leadership style that is based on orders and directives. (LO 6.3.3)

back stage: a persons' private world that they choose not to reveal. (LO 4.4.1)

beliefs: ideas generally held to be true within society. (LO 3.2.2)

bisexual: individuals with a sexual orientation to both sexes. (LO 9.4.1)

blended family: a family in which one or both spouses have children from previous relationships. (LO 13.2.1)

blue-collar worker: an individual who engages in manual labor. (LO 8.1.1)

bourgeois: the small minority who were the wealthy class. (LO 1.1.2)

breaching: purposely violating social norms to examine individual's reactions. (LO 5.1.2)

bureaucracy: a hierarchical authority structure that uses task specialization, operates on the merit principle, and behaves with impersonality. (LO 1.2.2; LO 6.2.2)

capital punishment: a penalty for criminal behavior that results in the death of the perpetrator. (LO 7.4.1)

capitalism: an economic and political system based on private control of the production and distribution of goods and services within a free market system. (LO 11.2.1)

carrying capacity: the numbers of people a geographic location or the earth's ecosystems can support without deterioration. (LO 15.2.1)

case study: an in-depth analysis of a particular person, place, or event over a significant period of time. (LO 2.4.1)

caste system: a type of closed stratified system in which people are designated to a particular social position based on their parents' status in the society. (LO 8.2.1)

centenarians: individuals age 100 and above. (Chapter 14 Opener)

child abuse: the physical, emotional, or sexual harm or mistreatment of a child. (LO 13.3.2)

childfree: individuals who choose not have children. (LO 13.2.3)

childless: individuals who cannot have children for biological reasons. (LO 13.2.3)

chronic diseases: long-lasting health problems that normally cannot be cured and only controlled, such as heart disease, cancer and strokes. (LO 14.1.2)

civic participation: individual and collective action to address issues of public concern. (LO 11.1.1)

climate change: the weather impacts of the rising temperatures. (LO 11.1.3)

class consciousness: an awareness of one's social category within a social hierarchy. (LO 8.1.1)

class system: a type of open stratified system that allows social mobility. (LO 8.2.1)

collective behavior: spontaneous and unstructured behavior engaged by large groups of people. (LO 15.1.1)

closed system: a social system that that does not allow for social mobility. (LO 8.2.1)

code of ethics: a set of guidelines of appropriate behavior established by an organization for its members to follow. (LO 2.3.2)

coercive organization: groups of people whose membership are primarily forced and must abide by strict rules and regulations. (LO 6.2.1)

cohabitation: a residential pattern in which a couple lives together without the benefit of legal marriage. (LO 13.1.1)

collective conscience: A set of shared attitudes, beliefs, and ideas about how things should be in society. (LO 7.3.4)

communism: an economic and political system based on the ownership and regulation of all of the production and distribution of goods and services by the government. (LO 11.2.1)

- Community Supported Agriculture (CSA): a system in which individuals purchase shares of food in advance of production from local farmers. (LO 14.1.2)
- **confidentiality**: guarding who has the right of access to the data provided by the participants. (LO 2.1.2)
- **conflict theory:** a macro theory based on class struggles and exploitation. (LO 1.1.2; LO 1.3.2)
- **conspicuous consumption:** the public display of lavish and wasteful spending to enhance one's social status. (LO 5.2.1)
- **constitutional monarchy:** a system of government in which a monarch is the Head of State and governed by a parliament. (LO 11.2.1)
- **contact hypothesis:** the idea that prejudice decreases when two groups of equal status come into contact. (LO 10.5.2)
- **contagion theory:** unconventional behaviors resulting from a crowd infested with illogical and irrational beliefs. (LO 15.1.2)
- **containment theory:** individuals have various social controls that provide a protective barrier to help them resist engaging in deviant and criminal behavior. (LO 7.1.4)
- **content analysis**: a systematic method of assigning codes to text, video, and music to analyze and infer patterns. (LO 2.2.2)
- **control group**: the subjects who are not exposed to the independent variable and are used as a reference group. (LO 2.2.1)
- **countercultures:** groups that are in opposition or contrast with the majority of the members of a society. (LO 3.3.3)
- **counterfeiting:** the manufacturing and selling of illegally copied products. (LO 7.5.1)
- **courtship:** seeking the affections of an individual, or establishing contractual terms, usually with the intent of forming a long-term relationship. (LO 13.1.1)
- **covenant marriage:** a legally binding marriage requiring pre-marital counseling and more limited grounds for divorce. (LO 13.1.2)
- **convergence theory:** crowds form due to like-minded individuals coming together. (LO 15.1.2)
- **crime:** an offence in violation of public law. (LO 7.1.3)
- **crime rate:** a statistical count of different categories of crime compiled by federal, state and local agencies. (LO 7.3.1)

- **criminal justice system:** formal institutions designed to enforce, arbitrate, and carry out the laws of the society. (LO 7.3.1)
- **crude birth rate:** the formula to determine the number of live resident births for a specific location and time period. (LO 15.2.1)
- **cult of domesticity:** the glorification of a white middle to upper middle-class ideal that placed value on women for their sexual purity, morality, domestic abilities and submissiveness to men. (LO 9.5.1)
- **cultural capital:** the information, knowledge and ideas that a person uses to support their social mobility. (LO 8.4.1)
- **cultural diffusion:** the spread of norms, values, knowledge, symbols, and material components from one society to another. (LO 3.5.1)
- **cultural imperialism:** the influence and power of one country's culture upon a country as a result of importing goods and services. (LO 3.3.1)
- **cultural lag:** the process by which technological development and progress outpace current norms, values, knowledge, symbols, and material components of society. (LO 3.5.1)
- **cultural leveling:** the process of cultures becoming similar as a result of factors such as media and globalization. (LO 3.5.1)
- **cultural relativism:** understanding another culture from their standards. (LO 3.4.3)
- **cultural transmission:** the means by which culture is passed from generation to generation. (LO 3.2.3)
- **cultural universals:** aspects of culture that are found in all societies. (LO 3.4.1)
- **culture:** the socially learned and shared ideas, behaviors and material components of a society. (LO 3.1.1)
- **culture shock:** surprise, disorientation, or fear when encountering a new culture. (LO 3.1.1)
- **cyber crime:** crime that targets the computer systems of an individual or group. (LO 7.3.1)
- **cyberslacking:** when workers spend an excess amount of time on-line for personal reasons that do not benefit their employer. (LO 6.5.1)
- **debriefing**: a follow-up review of the research. (LO 2.3.2)
- de facto segregation: segregation that happens "by fact" rather than requirement. (LO

deindividuation: a loss of individuality. (LO 15.1.1)

democracy: a system of government in which the power is vested in the people and free elections are held. (LO 11.2.1)

democratic leader: a leadership style based on increasing harmony and reducing conflict between group members. (LO 6.3.3)

demography: the statistical study of births, migration, aging, and death in relation to population dynamics. (LO 15.2.1)

denominations: a distinct group of churches with a common doctrine and name. (LO 12.1.4)

dependency theory: a macro theory indicating the stratified world economic system keeps peripheral nations dependent on core nations. (LO 8.3.2) **dependent variable**: a factor that is changed by another variable. (LO 2.1.2)

deprofessionalism: a decline in the power of a profession. (LO 14.1.2)

desegregation: the elimination of the policy of segregation by legal and social means (LO 10.2.2)

deviance: violation of social norms. (LO 7.1.1)

dictatorship: form of government to which political authority is controlled by a single person or political entity. (LO 11.2.2)

differential association theory: individuals learn deviant and criminal behavior from associating with deviants and criminals. (LO 7.1.3)

differential justice: differences in how groups are treated in the criminal justice system. (LO 7.3.2)

digital divide: the access to and ability to use technology like computers and the internet. (LO 8.4.1)

digital immigrants: people who do not grow up with current technologies and have to learn and adapt to technology and social media later in life. (LO 4.2.3)

- **digital natives:** those individuals who have always experienced a totally digital world. (LO 4.2.3)
- **direct population transfer:** when the dominant group makes a minority group population leave a location by force. (LO 10.3.3)
- **disenfranchisement:** an effort to restrict or revoke the voting rights of an individual or group. (LO 11.3.3)
- **distance learning:** college level schooling that occurs online at a time and place convenient to the student. (LO 12.5.2)
- **distance zones:** the amount of space we are socialized to feel comfortable having between ourselves and others. (LO 4.4.2)
- **diversity:** the recognition and respect of the different attributes of races and ethnicities. (LO 10.1.5)
- **dominant ideology:** the beliefs and interests of the majority. (LO 3.3.1)
- **downsizing:** a reduction in the number of employees that work for the corporation. (LO 11.4.1)
- **dramaturgy:** the theory that we are all actors on the stage of life, and as such we divide our world based on what we let the others see or not see of us. (LO 4.4.1; LO 5.1.3)
- **dyad:** a group of two people. (LO 6.1.1)
- **dysfunction**: the undesirable disruptions of social patterns and resulting negative consequences within society. (LO 1.1.2)
- **economic systems:** a framework for the production and allocation of goods and services within a society. (LO 11.2.1)
- **education:** the transmission of knowledge, skills, values, and beliefs from one group to another. (LO 12.3.1)
- **elder abuse:** the physical, emotional, sexual, and financial abuse or exploitation of an elder by a caregiver or trusted individual. (LO 13.3.2)
- **emergent norm theory:** members of the crowd serve as a reference group and new norms emerge that legitimize the behavior as appropriate. (LO 15.1.2)
- **emoticons:** a symbol that is a type of shorthand, which is a means of expressing emotions and attitude within text-based communications. (LO 3.2.1)

- **emotion labor:** a worker's regulation of personal feelings in an effort to set an emotional tone for customers in a business setting. (LO 5.4.1)
- **employment-based health insurance:** a system in which an employer pays all or part of the health insurance premiums for the employee. (LO 14.2.2)
- **endogamy:** marrying or establishing a relationship within one's own social group or category, as required by custom or law. (LO 13.1.2)
- **estate system:** a type of closed stratified system in which wealthy land owners and peasants exist. (LO 8.2.1)
- ethics: principles of conduct about how you are supposed to behave in a given situation. (LO 2.3.2)
- **ethnicity:** social and cultural characteristics that set apart one group of people from another. (LO 10.1.1)
- ethnocentrism: judging another culture by one's own standards. (LO 3.4.2)
- **ethnography**: descriptive account of social life and culture in a particular social system derived from the researcher being embedded over a period of time within the group, organization, or community. (LO 2.2.2)
- **ethnomethodology:** the study of people's methods as it relates to the formation of society. (LO 5.1.2)
- **experiment**: the use of two or more groups in which one group is exposed to a factor being examined. (LO 2.2.1)
- experimental group: the study subjects exposed to the independent variable. (LO 2.2.1)
- **expressive leadership:** expressive leaders endeavor to establish more personal or primary connections with the group members. (LO 6.3.3)
- **exogamy:** marrying or establishing a relationship outside of one's own social group or category. (LO 13.1.2)
- **extended family:** a family that has other kin such as grandparents, aunts, uncles, and cousins living in the same household or nearby. (LO 13.2.1)
- face work: the efforts exerted by both actors during an interaction to get through unanticipated events without casting an undesirable light or disrupting the relationship of the participants. (LO 5.1.3)

fad: a craze or behavior quickly adopted by large groups of people that then fades in popularity rapidly. (LO 15.1.1)

fair trade: an organizational movement and certification process to help producers in developing countries receive a fair price for their products with the goals of reducing poverty, providing for the ethical treatment of workers and farmers, and promoting environmentally sustainable practices. (LO 1.3.1)

family: a group of people connected by blood, marriage, adoption or agreed upon relationship.

Families are socially constructed and historically changing. (LO 13.1.1)

family of orientation: the family in which you are raised and socialized as a result of birth, adoption, or a blended family. (LO 13.2.1)

family of procreation: the family you choose to create through marriage, agreed upon relationship, or the birth or adoption of children. (LO 13.2.1)

Federal Poverty Line: a governmental standard of measurement indicating the income level of when an individual or family is designated as poor. (LO 8.2.2)

feeling rules: norms about which emotions are appropriate to display in a given situation. (LO 5.4.1)

feminine-expressive role: providing care and emotional support. (LO 9.1.1)

femininity: traditional behaviors and traits associated with women. (LO 9.1.1)

feminism: a social movement that aims to establish equality between the sexes. (LO 9.5.1)

feminist: a person who believes in the legal political, social and economic equality between the sexes. (LO 9.5.1)

feminist theory: a view pertaining to anti-oppression, gender relations, and gender inequality. (LO 1.1.5)

feminization of poverty: the disproportionate number of women amongst the world's poor.

feral children: children who are isolated and neglected such that they are raised without socialization. (LO 4.3.1)

fertility rate: the average number of children born to a woman over her lifetime. (LO 15.2.1)

first-generation college student: the first person in the immediate family to attend college. (LO 3.1.1)

folkways: informal and common norms that guide every day behavior. (LO 3.2.3)

focus group: a small group interview or guided discussion using a moderator to gain insight of

the participants' opinions on specific topics. (LO 2.2.2)

formal organizations: structured and bureaucratic systems regulated by clearly stated norms and rules. (LO 6.2.1)

formal social control: groups and organizations whose specific function is to control the behavior of members of societies and reinforce social norms. (LO 7.1.1)

free range parenting: a style of parenting that deemphasizes scheduling and supervision and emphasizes extreme independence. (LO 13.2.4)

front stage: a persons' public life that they reveal to the world. (LO 4.4.1)

functionalist theory: a macro view of how the parts of society serve to maintain stability. (LO 1.1.2)

fundamental attribution error: the bias of attributing our behavior to our circumstances and the behavior of others to their character. (LO 1.3.2; LO 5.1.1)

fundamentalism: a strict adherence to conservative religious ideology. (LO 12.1.3)

game stage: taking the role of multiple people at one time. (LO 4.1.2)

gay rights movement: a variety of different organizations seeking to establish legal and social equality for members of the LGBT community. (LO 9.5.1

Gemeinschaft: a close-knit community characterized by personal and mutual bonds. LO 15.1.3)

Gesellschaft: a large urban area characterized by formal and impersonal relationships. (LO 15.1.3)

gender: the socially learned expectations and behaviors associated with being male or female. (LO 9.1.1)

gender identity: an individual's inner sense and identification of being a male or female. (LO 9.1.2)

gender norms: behaviors or traits that society attributes to a particular sex. (LO 9.1.2)

gender roles: public expression of one's gender identity. (LO 9.1.2)

- **gender stratification:** the unequal access and distribution of wealth, power, and privilege between women and men. (LO 9.2.2)
- **General Social Survey (GSS)**: a national survey on contemporary American society in order to monitor and explain trends and contrasts in attitudes, behaviors, and attributes.

- **generalized other:** the process of internalizing societal norms and expectations. (LO 4.1.2)
- **genocide:** the systematic killing of one group by another based on differences of race and/or ethnicity. (LO 10.3.4)
- glass ceiling: social and legal barriers designed to prevent minorities and women from advancing in the workplace. (LO 9.2.2; LO 10.4.2)
- glass escalator: men in female-dominate careers rise faster than women in maledominated careers. (LO 9.2.2)
- **global aging:** the rise in the percentage of elderly in developed countries and the accompanying economic and world order effects. (LO 15.2.2)
- **global inequality:** the stratification that exists between people living in different nations. (LO 8.5.1)
- **global warming:** the rise in surface temperature on the planet. (LO 11.1.3)
- **globalization:** the world-wide integration of our cultural, economic, and political lives that result from ever increasing levels of business, trade and technology. (LO 1.5.1)
- **graying of America:** the rise in the percentage of elderly in the U.S. that creates structural challenges for families, government, and the economy. (LO 15.2.2)
- **greenwashing:** promotion of being a sustainable and green company, when in fact sustainable practices are not the norm for the organization. (LO 6.2.1)
- **group:** people who identify and interact with one another. (LO 6.1.1)
- **group conformity:** aligning attitudes and behaviors with group norms. (LO 6.1.3)
- **groupthink:** the tendency of group members to yield to the desire of consensus rather than expressing individual or alternative ideas. (LO 2.2.2; LO 6.1.4)
- hate crime: criminal behavior directed at individuals or groups based on their race, ethnicity, disability, gender, gender identity, sexual orientation, or religion. (LO 7.3.1; LO 10.4.1)

- **Hawthorne effect**: the tendency of people to change their behavior when they know they are being watched. (LO 2.3.2)
- **health:** a state of complete physical, mental, and social well-being, and not merely the absence of disease or infirmity. (LO 14.1.1)
- **helicopter parent:** a well-meaning overprotective and overly involved parent that does not promote the characteristic of independence. (LO 13.2.4)
- **herd immunity:** a population's ability to resist a disease as a result of a high percentage of its members being immune. (LO 14.4.1)
- **heterosexual:** individuals with a sexual orientation to individuals of the opposite sex. (LO 9.4.1)
- **heterosexism:** prejudice or discriminatory attitudes and behaviors against homosexuals and homosexuality. (LO 9.4.2; LO 12.2.3)
- **hidden curriculum:** the lessons that are not associated with the formal educational curriculum. (LO 4.2.2; LO 12.3.2)
- **high culture:** consists of cultural characteristics associated with the dominant and elite members of society. (LO 3.5.2)
- high-status youth: those who are viewed as being popular among peers. (LO 4.2.1)
- **Hispanic mortality paradox:** the conditions by which Hispanics live longer despite lower income and health care access. (LO 14.2.1)
- **homogamy:** marrying or establishing a relationship with someone with similar social and economic characteristics. (LO 13.1.1)
- **homophobia:** the fear of homosexuals and homosexuality. (LO 9.4.2)
- **homosexual:** individuals with a sexual orientation to individuals of the same sex. (LO 9.4.1)
- **honor killing:** the killing of a female family member for the perceived shame she has brought upon the family. (LO 9.3.1)
- **hookups**: a sexual encounter, usually lasting only one night, between two individuals who are strangers or brief acquaintances. (LO 9.4.1)
- horizontal mobility: movement within a layer of the system of stratification. (LO 8.4.2)
- **hostile environment:** an intimidating, hostile, or offensive work environment due to unwelcome verbal or physical conduct of a sexual nature. (LO 9.2.2)

human trafficking: a situation in which a person is smuggled, abused and forced to work against their will for the economic gain of another. (LO 1.3.1)

hypothesis: an educated guess about a relationship between two or more situations, events, or factors. (LO 2.1.2)

"I": the unsocialized or acting self, made up of personal desires and needs.

income: money earned on a regular basis through work. (LO 8.1.1)

index crime: eight forms of criminal behavior used by the FBI to create the Uniform Crime Report. (LO 7.4.1)

in-depth interview: a one-on-one open-ended method that probes for deeper meaning and understanding of the responses of the interviewee. (LO 2.2.2)

in-group: a social unit to which an individual belongs and feels a sense of "we." (LO 6.1.2)

independent variable: a factor that causes a change in another variable. (LO 2.1.2)

indirect population transfer: when the minority group population chooses to leave a location. (LO 10.3.3)

infant mortality rate: the number deaths of children less than one year of age per 1,000 births. (LO 14.2.1; LO 15.2.1)

informal organizations: a system of the personal contacts and relationships of groupings of people. (LO 6.2.1)

informal social control: individuals and groups that unofficially reinforce social norms. (LO 7.1.1)

informed consent: a signed statement by participants indicating full knowledge of the risks involved and acknowledgment of the procedures to willingly withdraw from the study at any time. (LO 2.1.2)

institutional discrimination: the use of social institutions to deny minority group members access to the benefits of society. (LO 10.3.1)

institutional racism: societal patterns that produce negative treatment against groups of people based on their race. (LO 10.1.4)

Institutional Review Board (IRB): a committee that reviews research proposals to protect the rights and welfare of human participants in research. (LO 2.1.2)

instrumental leadership: instrumental leadership is very task-oriented. (LO 6.3.3)

internal colonialism: the exploitation of a society's minority group by its dominant group.

intersex: a person born with a combination of male and female sexual organs. (LO

9.4.2) intragenerational mobility: an individual's change in status during a lifetime. (LO

8.4.2) intergenerational mobility: an individual's change in social status that results

from mobility on

iron law of oligarchy: a system in which the concentration of power in a democracy rest in the hands of a few elite leaders. (LO 6.3.1)

laissez-faire capitalism: a system of free enterprise without government intervention. (LO 11.2.1)

laissez faire leader: a leader that takes a hands-off approach to leadership. (LO 6.3.3)

language: words and symbols used to communicate. (LO 3.2.1)

latent functions: unintentional and informally sanctioned functions of social institutions and society. (LO 1.1.2)

laws: formal and legal rules enforced by the state. (LO 3.2.3)

- **leaders:** individuals or groups who help facilitate, guide, and be the representative voice of its members. (LO 6.3.3)
- **life chances:** the opportunities and resources a person has at their disposal to improve their quality of life. (LO 8.4.1)
- **life course perspective:** a series of social changes that a person experiences over the course of their lifetime. (LO 4.5.1)
- **life expectancy:** the statistical average number of years a person is expected to live. (LO 15.2.2)
- **literacy:** the ability to use the skills of reading and writing to shape ones world. (LO 12.4.1)
- **lobbyist:** individuals who persuade legislators to vote for a special interest of their group. (LO 11.2.3)
- **longitudinal design:** the repeated observation of the same subjects over a duration of time. (LO 2.2.1)
- **looking-glass self:** the process of imagining the reaction of others toward oneself. (LO 4.1.3)
- **lower class:** the lowest category of people within a social hierarchy. (LO 8.2.2)
- **macro sociology:** a level of analysis focusing on social systems and populations on a large scale. (LO 1.1.2)
- **majority group:** a group that controls the economic, social, political power, and resources. (LO 10.2.1)
- **majority-minority:** when a population or district consists of over 50 percent minorities. (LO 10.2.1)
- **manifest function:** intentional and formally sanctioned functions of social institutions and society. (LO 1.1.2)

working poor: individuals who spend more than 27 weeks per year in the paid labor force and live below the poverty line. (LO 8.2.2)

world-system theory: any historical social system of interdependent parts that form a bonded structure and operate according to distinct rules. (LO 8.3.2)
